General Information

Food for special medical purposes:

Low volume, very high energy (5 kcal/mL) oral fat-based supplement with long and medium chain triglycerides. For the dietary management of patients with or at risk of malnutrition, especially with anorexia, low volume requirements and/or conditions requiring a high energy intake.

Dosage:

Must be determined by the healthcare professional according to patients' needs. Recommendation for supplementary nutrition: 4 x 30 mL spread over the day. The intake should not exceed 50% of patients' total energy needs or as advised by a healthcare professional. Suitable for vegan diet.

Important notice:

To be used under medical supervision. Not suitable as the sole source of nutrition. Suitable for oral energy supplementation only. Assure adequate protein and micronutrient supply. Not suitable for children <3 years. Ensure adequate fluid intake.

Not for parenteral (I.V.) use!

Instructions for use:

Shake well before use. Store at room temperature. Opened bottles may be stored in a refrigerator for up to 24 hours.

Additional considerations:

Not suitable whenever enteral nutrition is not permitted such as in acute gastrointestinal bleeding, ileus and shock. Use with caution in severe organ failure with impaired metabolism and severe forms of malassimilation. Not suitable for patients with congenital inability to metabolise nutrients contained in Fresubin 5 kcal Shot.

Fresubin 5 kcal SHOT Lemon: Water, rapeseed oil, medium chain triglycerides (MCT), sucrose, emulsifier (E 472c), flavourings, stabiliser (E 460, E 466), thickener (E 415).
